**Objectives of review seminars:** Review seminars developed and presented from an appropriate curriculum may provide guidance when preparing for licensing/certifying examinations. Having better prepared candidates for licensure may increase the number of qualified individuals who pass the licensing/certifying examinations and may be employed in the analysis of clinical specimens.

**Purpose of collecting post examination test scores:** CAMLT will be collecting post examination test status to help determine the efficacy of review seminars directed toward California licensure. The purpose of maintaining practice and post examination statistics is to continuously update curriculum reviewing the subject matter evaluated by licensing/certifying examinations and to determine if the curriculum developed will improve test scores of candidates for licensure.

**Techniques:** A curriculum will be presented for review seminars that will include the following topics:

All topics will be presented as examination review six-day seminars. In addition, test strategies unique to licensing/certifying examinations will be discussed. **Registrants will be asked to participate in a study (at no additional cost), which include a scored practice examination and the collection of licensing application status. Registrants are free to choose not to participate in this study and attend the seminar only.**

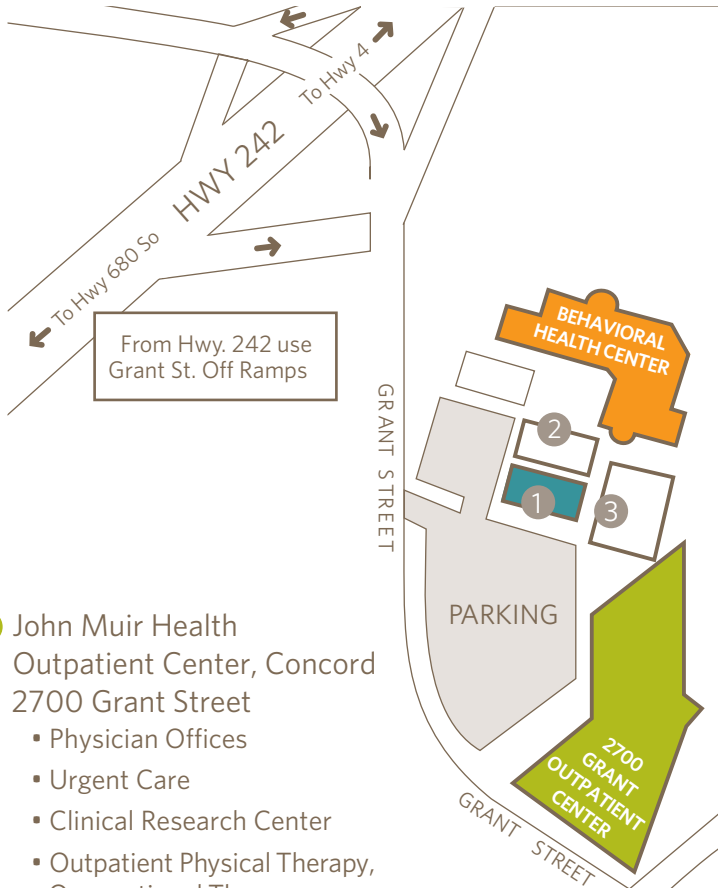
